- C. Motion by Schmidgall, second by Norris to accept a bid from Big Dog Power Washing in the amount of \$5,000 to clean the City water tower. Motion carried 7-0. YES-Norris Hoselton Kinate Weber Hoffman Dameron Schmidgall
- D. Motion by Hoselton, second by Kinate to approve Ordinance No. 2019-1 Amending A Part of Chapter 5, Section A, Of The Municipal Code Of The City Of Fairbury, Illinois In Relation To Water Rates And Charges. Motion carried 7-0. YES-Norris Hoselton Kinate Weber Hoffman Dameron Schmidgall
- E. Motion by Weber, second by Schmidgall to approve the purchase of a skid loader bucket in the amount of \$1,400. Motion carried 7-0. YES-Norris Hoselton Kinate Weber Hoffman Dameron Schmidgall
- F. Motion by Kinate, second by Dameron to approve an invoice from ArchiveSocial in the amount of \$2,388 for the next 12 months for FOIA purposes of the City's social networking accounts. Motion carried 7-0. YES-Norris Hoselton Kinate Weber Hoffman Dameron Schmidgall
