Ordinance No. 2020- 13

AN ORDINANCE AMENDING PARTS OF CHAPTER 6  
OF THE MUNICIPAL CODE OF THE CITY OF FAIRBURY OF 1982  
IN RELATION TO GARBAGE COLLECTION SERVICE CHARGES

Whereas, garbage collection charges are billed monthly on the water and sewerage bills to those recipients of water and sewerage who also receive garbage collection, and

Whereas, the City of Fairbury garbage collection billed are for services associated with garbage produced on property are for those who reside on the property, and

Whereas, garbage brought from other locations will not be accepted, and

Whereas, the City of Fairbury offers dumpsters to residential properties receiving garbage collection charges on their water and sewerage bills, and

Whereas, the availability of dumpsters is limited and dumpsters are provided on a first come, first serve basis.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Fairbury, Livingston County, Illinois as follows:

SECTION I

Chapter 6, Section .04 (e) (i) of the Municipal Code of the City of Fairbury of 1982 is hereby amended to read as follows:

The regular garbage collection charges established hereby will be billed to those receiving garbage collection services every **month**. The bill will be sent with the water and sewerage bill for those recipients of garbage collection services who also receive water and sewerage services from the City of Fairbury. The bill will be sent separately to such recipients of garbage collection services who do not receive water and sewerage services from the City of Fairbury. Persons receiving water and sewerage services from the City of Fairbury will be presumed to also be receiving garbage collection services from the City of Fairbury. Any such person who is not receiving garbage collection services shall be responsible for notifying the City of that fact.

SECTION II

Chapter 6, Section .05 of the Municipal Code of the City of Fairbury of 1982 is hereby amended to read as follows:

The following regulations shall apply to all garbage picked up by the City of Fairbury. Any

garbage which is not set out in compliance with these regulations shall not be picked up by the City of Fairbury: (1988-2)

- (a) All residential garbage shall be placed in containers no greater than thirty gallon in capacity and having a maximum weight of no more than seventy-five pounds. (1988-2)
- (b) All non-residential garbage shall be placed in containers no greater than thirty gallon in capacity and having a maximum weight of no more than seventh-five pounds or in dumpsters which shall have a maximum capacity of no more than 3.0 cubic yards. No loose garbage, either residential or non-residential, shall be picked up by the City, but shall be put in containers approved by the City of Fairbury, except as otherwise herein provided. (1988-2)
- (c) No loose leaves or grass clippings shall be picked up by the City of Fairbury. Leaves and grass clippings need not be placed in approved containers but if not placed in approved containers, must be placed in plastic garbage bags. No cardboard boxes, including appliance or furniture cartons, shall be picked up by the City unless they have first been cut up and flattened prior to disposal. (1988-2)
- (d) All garbage must be taken to the City coping, alley, or street before it will be picked up by the City. The City will not enter onto private property to pick up garbage except in the case of dumpsters which must be located at points approved by the City. (1988-2)
- (e) The City will only collect garbage that is from the property that is being picked up. Garbage brought from other properties will not be accepted.**

### SECTION III

Chapter 6, Section .07 of the Municipal Code of the City of Fairbury of 1982 is hereby created to read as follows:

#### **.07 RESIDENTIAL USE OF CITY DUMPSTERS**

**The City will provide a dumpster, as available, upon request to residential properties. The City will take into consideration requested area for dumpster to be placed but does not guarantee requested placement.**

**Dump fees will coincide with non-residential dumpster fees and said fees will be added to monthly utility bills issued by the City with the following regulations:**

- (a) Dumpsters will be allowed for use up to 30 calendar days. Upon 30 days, the City will retrieve the dumpster. The dumpster will be emptied and dumping fees will be applied. Another dumpster cannot be requested within 10 days of previous dumpster removal.**
- (b) The City is to be notified prior to 30 days for needs of more than 30 days. An additional fee of \$4 per day will be applied in addition to normal dumping fees for any additional days past the initial 30-day allowance.**

**The City will dump the dumpster upon request made to City Hall. The City holds the right at any time to retrieve a City dumpster from a residential property.**

SECTION IV


All ordinances or resolutions or parts thereof in conflict with the provisions of this ordinance are to the extent of such conflict hereby repealed.


