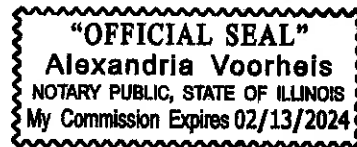

AN ORDINANCE AMENDING CHAPTER 7
OF THE MUNICIPAL CODE OF THE CITY OF FAIRBURY OF 1982
IN RELATION TO SOLICITORS

Whereas, the City of Fairbury adopted its Municipal Code Book in 1982, and

Whereas, Chapter 7 of the Municipal Code Book of the City of Fairbury pertains to Offenses, and

Whereas, Section .15 of Chapter 7 of the Municipal Code Book of the City of Fairbury pertains to Peddlers, and

Whereas, it is necessary to amend parts of Section .15 of Chapter 7 of the Municipal Code Book of the City of Fairbury of 1982 as certain abuses have occurred and continue to occur with unapproved, aggressive, and dishonest solicitation within the City of Fairbury.

NOW, THEREFORE, be it ordained by the City Council of the City of Fairbury, Livingston County, Illinois as follows:

SECTION I

Chapter 7, Section .15, III, D., CREDENTIALS, shall be amended to read;

D. CREDENTIALS

Upon approval of the application for a permit, as hereinbefore stated, the City Clerk shall issue credentials to the applicant **whose** credentials shall be issued **in** the name of the City Clerk, and to which shall be appended a photograph of the applicant. Such credentials must be worn by the solicitor **at all times** within the City **limits regardless of whether the solicitor is on private or public property**. The credentials will be worn in such a manner as to be readily visible to all individuals being solicited. **Each solicitor shall wear a reflective vest provided by the City upon payment of a \$50 cash deposit. Such deposit will be returned to the solicitor when the reflective vest is returned in the same condition as it was given to the solicitor. Failure to return the vest within fourteen (14) days from the date of issue will result in the forfeiture of the \$50 cash deposit. Failure to return the vest in the same condition as it was given may result in forfeiture of all or part of the \$50 cash deposit.**

SECTION II

This ordinance shall be effective after passage by the City Council of the City of Fairbury, Illinois, and its approval by the Mayor of the City of Fairbury, Illinois, and its publication in pamphlet form as required by law.
