**AN ORDINANCE FOR THE LEVY AND ASSESSMENT OF TAXES
 FOR THE FISCAL YEAR ENDING APRIL 30, 2021**

Whereas, the City Council of the City of Fairbury, Livingston County, Illinois did on July 15, 2020 pass the final appropriation bill for said City for the fiscal year ending April 30, 2021, the amount of which is ascertained to be the aggregate sum of \$16,751,050 which said appropriation bill was duly published on July 16, 2020,

NOW THEREFORE be it ordained by the City Council of the City of Fairbury, Livingston County, Illinois as follows:

SECTION I

That there be and is hereby levied upon all taxable property within the corporate limits of the City of Fairbury, Livingston County, Illinois, subject to taxes for the year 2020, payable in 2021, the total sum of \$916,065 for the following specific purposes mentioned in said appropriation bill and in the respective sums as follows:

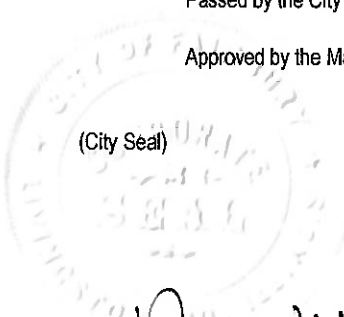


