Ordinance No. 2024-

AN ORDINANCE AMENDING PARTS OF CHAPTER 6 OF THE MUNICIPAL CODE OF THE CITY OF FAIRBURY OF 1982 IN RELATION TO REFUSE AND GARBAGE

Whereas, the City of Fairbury offers dumpsters to residential properties receiving garbage collection charges on their utility bills, and

Whereas, the availability of dumpsters is limited and dumpsters are provided on a first come, first serve basis, and

Whereas, it has become necessary to implement a system to better regulate dumpster rentals.

NOW, THEREFORE, be it ordained by the City Council of the City of Fairbury, Livingston County, Illinois that Chapter 6 of the Fairbury Municipal Code of 1982 shall be amended to read as follows:

SECTION I

.08 RESIDENTIAL USE OF CITY DUMPSTERS (2024-09)

The City will provide a dumpster, as available, upon request to residential properties. At the time of request, the resident will be required to fill out and sign a rental agreement. This is to be returned to City Hall prior to the delivery of said dumpster. The City will take into consideration requested area for the dumpster to be placed but does not guarantee requested placement.

The dumpster rental fee and dump fees of \$13 per yard will coincide with non-residential dumpster fees and said fees will be added to monthly utility bills issued by the City with the following regulations:

- a) Dumpsters will be charged \$1.50 per day of possession for the first 30 calendar days. After 30 days, the cost will increase to \$4 per day until dumpster is returned to the City.
- b) The holder of the dumpster will need to call when the dumpster is needing to be dumped and/or said dumpster is ready for the City to remove it from the property. Once the dumpster is

removed from the property, the dumpster will be emptied and all accrued fees will be applied. Another dumpster cannot be requested within 10 days of previous dumpster removal.

c) If a resident has had City utility services disconnected for nonpayment, the resident's dumpster may be seized at this time.

The following materials are <u>not</u> permitted in City dumpsters:

- Liquid Chemicals
- Paint
- Shingles
- Bricks/Concrete
- Electronics
- Tires
- Car Batteries
- Heavy Metals
- Yard Debris

If these items are found in the dumpster, the dumpster will be seized and a \$100 fine as well as a dump charge will be added to the resident's City utility account. If the resident commits a second offense, they will no longer be eligible for dumpster rental.

In addition, City dumpsters are not to be used for household garbage, dumpsters should not be filled more than 12" above the height of the dumpster and are not to be requested for use by hired contractors. These dumpsters are available for use by residences of Fairbury only.

The City holds the right at any time to retrieve a City dumpster from a residential property.

SECTION II

All ordinances or resolutions or parts thereof in conflict with the provisions of this ordinance are to the extent of such conflict hereby repealed.

This ordinance shall be effective after passage by the City Council of the City of Fairbury, Illinois, and its approval by the Mayor of the City of Fairbury, Illinois, and its publication in pamphlet form as required by law.
